ORDER

Consequent upon the enactment of the Punjab Panchayati Raj Act 1994, the Punjab Gram Panchayat Act 1952 and the Punjab Panchayat Samitis and Zila Parishads Act 1961 were repealed but the following saving clause has been provided in sub section (3) of section 228 of the Punjab Panchayati Raj Act 1994:

"Notwithstanding such repeal, anything done or any action taken under the Acts so repealed (including any notification, order, notice issued, application made or permission granted), which is not inconsistent with the provisions of this Act shall be deemed to have been done or taken under the corresponding provisions of this Act as if this Act so enforced at the time such thing so done or action so taken and shall continue to be in force unless and until superseded by anything done or any action taken under this Act".

All the rules so framed under the repealed Acts were published through notifications in the Government Gazette from time to time. So far no new rules under the Punjab Panchayati Raj Act 1994, have been framed and published and the matter is under active consideration of the Government. Therefore, it has been decided that all the matters relating to the Panchayati Raj Institutions shall be governed under the rules (Annexure-R) framed under the repealed Acts so far as they are not inconsistent with the provisions of Punjab Panchayati Raj Act 1994, till the new rules are framed.
